All Applications take 3-5 Business days for completion. Upon approval a holding deposit equal to 1/2 months rent is due within 48 hours, to secure your rental off the market for your move in day. All utilities and renters insurance must be activated with proof for possession. Tenants have 4 days to cancel rental before holding deposit becomes non-refundable.

Execution of Lease Agreement is required for possession.

Pets:

Renters Insurance Required:

Cherry City Properties requires Renters Insurance policies for all Prospective Residents/New Move In's as well as Current Residents Renewing or going on a Month to Month Agreement. All residents are required to provide evidence of liability or property damage insurance at a minimum limit of \$100,000. The policy will need to cover property damage a resident may cause to the apartment as a result of fire, smoke, explosion and water; as well as list Cherry City Properties as an "Interested Party" or "Additional Interest". Please note that the Property Owners insurance does not cover a resident's possessions if they are damaged or stolen. To obtain coverage for your possessions we strongly recommend you purchase a policy that includes "contents/personal property" insurance.
